I. Background information

This Manual is the main output of the project Synergized Standard Operating Procedures (SSOP) for Coastal Multi-Hazards Early Warning System. It is intended to serve as an important reference to those that deal with EWS related to hydro-meteorological phenomena. Its drafting is being made by Mr. James Weyman, project manager/technical advisor of the SSOP project and is the result of intensive consultation of documents related to EWS, workshops, missions to six countries of the TC and PTC regions and advices from representatives of partner organizations and agencies. Collaboration was also given by members of the SSOP task force, SSOP steering committee, and SSOP focal points in the beneficiary and some non-beneficiary countries of the project.
