# Self-protection Think how to save your own life at risk

Nature could bring outcomes beyond our imagination – our knowledge is limited (no seismologists could predict EQ with magnitude 9.0 or higher in the offshore Japan)

Evacuation to safe places (higher ground vertically or horizontally)

No matter how warning and evacuation order is issued by authorities, some people do not evacuate. We need to analyze why to make a better policy.

# Discussion Point 1: Why people do not evacuate against the warning?

- Do not understand the risk (ignorance)
- Never been a problem in my place
- No trust at warning providers (false alarm, etc.)
- Getting used to warnings
- Working at an organization
- Try to save family members
- Sleeping
- Physically disabled (2-3 times death rates higher)
- No means to evacuate
- I am not afraid of it and I am OK
- A man of the family has to stay home to protect the house from hazards and rooters
- I cannot afford to evacuate for days
- If I evacuate, I cannot make money for days
